Spot Admission and Eligibility Requirements:

- Only the candidates that satisfy **both criteria A and B below** are ELIGIBLE for 'the Spot Admission' at IIT Goa.
A: Candidates who have applied for M.Tech. Program at IIT Goa (i.e., candidate having IIT Goa application No.) **AND**
B: Candidates who have **NOT TAKEN** admission in any other participating Institutes or NOT MARKED the "Accept & Freeze" option on the COAP.
- Additionally, for the **M.Tech in EE** program, the following category-wise GATE-score cutoff needs to be met for eligibility in the spot round:
 - UR: GATE score should be **greater than or equal to 471** for Gender Neutral seats.
- Candidates who have **CONFIRMED** admission to another academic unit of IIT Goa are **Not Eligible** for the '**Spot Admission**' at **IIT Goa** (i.e. change of program/branch is NOT allowed).
- All interested applicants who are ELIGIBLE as per the criteria above will need to **REGISTER** for an **ONLINE SPOT ADMISSION ROUND to be conducted on 01st August 2026**. The registration form and details will be shared with the eligible applicants via registered email.
- Details of the Spot admission round will be shared to the registered candidate's email-ID. Applicants who wish to participate should join the spot admission round 10 minutes before the start of the round in online mode and remain in the meeting until it concludes.
- For students of the OBC-NCL category, certificates of OBC-NCL should be obtained on or after 1 April, 2026 and for students of the EWS category, certificates of EWS should be obtained for the financial year 2026-27.
- Applicants who are offered a seat in the Spot round will be required to **confirm immediately and pay the seat confirmation fees** as applicable to their category (**Rs. 35,300/-** for General/OBC/EWS and **Rs. 30,300/-** for SC/ST/PwD category) on the spot **through an online payment gateway**. The fee details are available at link: [M.Tech fee structure](#). Failing to pay the fees will result in the seat being offered to the next candidate in the merit list.

8. When a seat is offered to a candidate during the spot round, temporary absence in the online meeting or a failure to pay the confirmation fees immediately will result in the seat being offered to the next candidate in the merit list. This process is final and irreversible; once a seat is forfeited, the candidate will not be reconsidered again.
9. Please note the fee paid for seat confirmation in the online spot admission round is **not refundable** under any circumstances.
