1 Introduction

Towards facilitating flexible & personalised learning as mandated by the New Education Policy 2020, Indian Institute of Technology Goa (IIT Goa) has formulated the following policy on Entry and Exit for its undergraduate (UG) programs. The guiding principle is that all exit levels are equally valid and are treated with no prejudice.

2 Entry Rules

Admission to various UG programs at IIT Goa is carried out through the Joint Entrance Examination (Advanced) (JEE (Adv)). The JEE (Adv) and the subsequent process of admission to IIT Goa shall be governed by the rules contained in the Information Brochure of JEE (Adv) (see https://jeeadv.ac.in/), read in conjunction with the Business Rules of the Joint Seat Allocation Authority (JoSAA) (see https://josaa.nic.in/).

3 Exit Levels

There are two (2) exit levels¹ for the four-year UG programs categorised by the credit requirements. The various options are listed in table 1.

Level	Qualification Title	Credit Requirements
L6	Diploma in Engineering (Diploma (Engg.))	45
L8	Bachelor of Technology (B. Tech.)	135 ²

Table 1: Qualification Type and Credit Requirements

3.1 Level 6 (L6)

To obtain a level 6 diploma, a minimum of 45 credits is required. The student will be awarded a Diploma in Engineering, or Diploma (Engg.) in abbreviation, with *no* specialisation.

3.2 Level 8 (L8)

To obtain a level 8 degree, a minimum of 135² credits and additional requirements specified in the UG manual of the institute are required. The student will be awarded a B. Tech. in the respective academic program.

4 Regulations

4.1 No-cause exit is permitted, i.e. the student can choose the exit voluntarily.

- 4.2 The exit options will only be available after the completion of at least four (4) semesters of the UG program.
- 4.3 The maximum period for completing any intermediate exit diploma/degree will be that of the original academic program as specified in the UG manual.
- 4.4 On termination on academic grounds, the student will be eligible for an exit degree at the appropriate level based on their earned credits.
- 4.5 Once approved by the Senate, the exit is final and irreversible.

5 Process of Approval

To apply for an exit at L6 (section 3.1), a student is required to fill out the prescribed application form. After verifying the credits, Program Undergraduate Committee (PUGC) will provide their comments on the application. Senate Undergraduate Committee (SUGC) will then recommend the application to the Senate. The Senate will confirm the award of the exit degree to the student. Once approved by the Board of Governors (BoG), the degree will be awarded to the student on the next Convocation of the institute.
