The Advisor will also guide retrofitting, preventive maintenance, and infrastructure lifecycle planning. Responsibilities include assisting in project management, contract review, cost estimates, and BOQ vetting. The Advisor is also expected to support B&WC agenda preparation and offer expert inputs.

2. The selected candidate is expected to join immediately.
