1.3. पात्रता के लिए मानदंड

- 1.3.1 प्रतिष्ठित विद्युत ठेकेदार जिनके पास सरकार द्वारा जारी उचित (एमवी या उससे ऊपर) वैध विद्युत ठेकेदार का लाइसेंस है। गोवा के और कम से कम तीन साल के लिए ठेकेदार का लाइसेंस रखने वाले पात्र हैं। यदि बोली लगाने वाले के पास वैध ठेकेदार लाइसेंस नहीं है, तो उसे काम की देखरेख के लिए एक लाइसेंस प्राप्त ठेकेदार की इच्छा होनी चाहिए, जिसे सरकार द्वारा ऐसा लाइसेंस जारी किया गया हो। एमवी श्रेणी या उससे ऊपर के विद्युत कार्य करने के लिए गोवा का। वैध लाइसेंस की एक प्रति (बोलीदाता और लाइसेंस धारक द्वारा सत्यापित) के साथ इच्छा पत्र (जैसा कि परिशिष्ट-डी में दिया गया है) संलग्न किया जाना चाहिए। लाइसेंस कार्य के निष्पादन अविध के दौरान वैध होना चाहिए।
- 1.3.2 बोली लगाने वाले के पास सरकारी/अर्धसरकारी संगठनों/सरकारी वित्त पोषित स्वायत्त संगठन द्वारा दिए गए समान प्रकृति के कार्यों का अनुभव होना चाहिए।
- 1.3.3 बोली लगाने वाले ने कम से कम सफलतापूर्वक पूरा किआ होना चाहिए 1 (एक) समान कार्य जिसका का मूल्य अनुमानित लागत के 80% (अर्थात 2,67,000/- रुपये) के बराबर या उससे अधिक या 2 (दो) समान कार्य, प्रत्येक का मूल्य अनुमानित लागत के 60% (अर्थात रु. 2,00,000/-) के बराबर या उससे अधिक या 3 (तीन) समान कार्य, प्रत्येक का मूल्य अनुमानित लागत के 40% (अर्थात रु. 1,33,500/-) के बराबर या उससे अधिक किसी सरकारी/अर्ध-सरकारी/पीएसय्/सरकारी वित पोषित स्वायत संगठन के साथ। उपरोक्त उल्लिखित कार्य निविदा जमा करने के माह की अंतिम तिथि से पिछले 7 (सात) वर्षों के दौरान पूरा किया जाना चाहिए। कार्य आदेश की प्रति और सीपीडब्ल्यूडी प्रारूप में पूर्णता प्रमाण पत्र संलग्न किया जा सकता है। पूर्णता प्रमाणपत्र पर ठेकेदार का नाम, दिए गए काम का मूल्य, काम का पूरा मूल्य, पूरा होने की निर्धारित तारीख, पूरा होने की वास्तविक तारीख, जुर्माना लगाया जाना चाहिए, यदि कोई हो तो ईई के रैंक से कम के हस्ताक्षर नहीं होना चाहिए।

- 1.3.4 कंपनी के पत्रशीर्ष पर इस आशय का प्रमाणपत्र/वचनपत्र कि बोली लगाने वाले को भारत या विदेश में कहीं भी किसी भी संगठन द्वारा काली सूची में नहीं डाला गया है। इस आशय का स्व-प्रमाणीकरण संलग्न करना आवश्यक है जैसा कि परिशिष्ट-ए में दिया गया है।
- 1.3.5 वितीय वर्ष 2020-21, वितीय वर्ष 2021-22 और वितीय वर्ष 2022-23 में से प्रत्येक के लिए बोली लगाने वाले का वार्षिक कारोबार अनुमानित लागत (अर्थात् 3,33,092/- रुपये) से कम नहीं होना चाहिए। वार्षिक कारोबार आयकर निकासी प्रमाणपत्र के अनुसार और विशेषेशाधिकारित लेखापाल द्वारा प्रमाणित होना चाहिए।
- 1.3.6 बोली लगाने वाले को निम्नलिखित की स्वप्रमाणित प्रतियां संलग्न करनी होगी;
 - A. 1.3.1 के अनुसार गोवा सरकार द्वारा जारी वैध विद्युत ठेकेदार लाइसेंस।
 - B. वस्त् एवं सेवां कर पंजीकरण प्रमाणपत्र।
 - C. स्थायी खाता संख्या कार्ड।
 - D. मानदंड 1.3.2 और 1.3.3 के अनुसार मुवक्किल से कार्य आदेश की प्रतिलिपि और पूर्णता प्रमाण पत्र।



- E. क.भ.नि. और क.रा.बी. पंजीकरण की प्रति। यदि बोलीदाता के पास क.भ.नि. और क.रा.बी. पंजीकृत नहीं है तो कंपनी के पत्रशीर्ष पर कारण सिहत एक पत्र जमा करना होगा और क.भ.नि./ क.रा.बी. का अनुपालन न करने पर किसी भी परिणाम के लिए बोलीदाता जिम्मेदार होगी।
- F. मानदंड 1.3.6 के अन्सार वार्षिक कारोबार का प्रमाण पत्र।
- 2. बोली लगाने वालों के लिए सूचना
- 2.1. कार्य का दायरा
- 2.1.1. कार्य क्षेत्र में इस एनआईटी के भाग-ख (वितीय बोली) में दी गई सभी मदों की आपूर्ति, स्थापना, परीक्षण और कमीशन शामिल होगा।
- 2.1.2. इस निविदा आमंत्रण सूचना के भाग बी (वितीय बोली) में दी गई वस्तुओं को केंद्रीय लोक निर्माण विभाग के "विद्युत कार्यों के लिए सामान्य विशिष्टताएं भाग 1 (आंतरिक) 2023 और भाग 2 (बाहरी) 2023" के अनुसार निष्पादित करना होगा।
- 2.2. सामान्य निर्देश
- 2.2.1. बोली दस्तावेज़ निम्नलिखित वेबसाइट से डाउनलोड के लिए उपलब्ध हैं: https://iitgoa.ac.in/tenders/
- 2.2.2. इस बोली दस्तावेज़ को सीपीडब्ल्यूडी के जीसीसी (अनुबंध की सामान्य शर्तें) और विद्युत कार्यों के लिए सामान्य विशिष्टताओं भाग 1 (आंतिरक) 2023 और भाग 2 (बाहरी) 2023 और वर्क्स मैनुअल 2022 और इसके अनुसार दिए गए लागू विनिर्देशों के साथ पढ़ा जाएगा। एसओपी. जब तक अन्यथा उल्लेख न किया गया हो, ये दस्तावेज़ इस अनुबंध के लिए मान्य होंगे। हालाँकि वृद्धि की लागत (10 सीए, 10 सीसी वगैरह) और सामग्री के विरुद्ध सुरक्षित अग्रिम इस अनुबंध पर लागू नहीं होगी।
- 2.2.3. यदि भाग लेने वाले बोलीदाता पूर्व-बोली बैठक में भाग लेने के इच्छुक हैं तो ऐसे बोलीदाताओं को je.electrical@iitgoa.ac.in पर एक मेल भेजना होगा और प्रति ex.eng@iitgoa.ac.in और estate@iitgoa.ac.in पर रखनी होगी उनके प्रश्नों के साथ। प्रासंगिक प्रश्नों का उत्तर प्री-बिड मीटिंग में दिया जाएगा जो निर्माण और संपदा प्रबंधन प्रभाग कार्यालय में होगी। निविदा को प्रभावित करने वाले किसी भी प्रश्न का उत्तर निविदा आमंत्रण सूचना का हिस्सा होगा और उसके लिए शुद्धिपत्र जारी किया जाएगा और ठेकेदार तदन्सार उद्धरण देगा।
- 2.2.4. बोली लगाने वाले को स्थल पर आकर निरीक्षण करना होगा और अपनी जिम्मेदारी और अपने खर्च पर सभी जानकारी प्राप्त करनी होगी, जो निविदा उद्धृत करने और जमा करने के उद्देश्य से आवश्यक हो सकती है। अनुबंध प्रदान करने के बाद साइट की स्थितियों और स्थानीय जानकारी के बारे में कोई बहाना या अज्ञानता स्वीकार नहीं की जाएगी। प्रभारी अभियंता द्वारा सभी कार्य दिवसों पर कार्य समय के भीतर स्थल तक पहुंच प्रदान की जाएगी।
- 2.2.5. संबंधित संगठन के लेटरहेड पर सक्षम प्राधिकारी द्वारा जारी पूर्णता प्रमाण पत्र को ही प्रमाण पत्र माना जाएगा। यदि सक्षम प्राधिकारी द्वारा जारी समापन प्रमाण पत्र कार्य के प्रकार को प्रतिबिंबित नहीं करता है, तो अंतिम बिल या अर्हता प्राप्त कार्यों की मात्रा की अनुसूची को समापन प्रमाण पत्र के साथ संलग्न करना आवश्यक है। पूर्णता प्रमाण पत्र में काम का नाम, काम शुरू होने की तारीख, वास्तविक पूरा होने की तारीख, पूरा होने की



निर्धारित तारीख, देरी के कारण, यदि कोई हो, अंतिम मूल्य, जुर्माना, यदि कोई हो, जैसे विवरण शामिल होंगे और किसी अधिकारी दवारा हस्ताक्षरित जो कि कार्यकारी अभियंता के पद से नीचे नहीं होना चाहिए।

- 2.2.6. बोली दस्तावेज़ (निष्पादित की जाने वाली विभिन्न प्रकार की वस्तुओं की मात्रा की अनुसूची, अनुबंध के नियमों और शर्तों का सेट और अन्य दस्तावेज़ / चित्र, यिद कोई हो), शुद्धिपत्र (यिद कोई हो) केवल इन वेबसाइटों पर प्रकाशित किया जाएगा: https://iitgoa.ac.in/tenders/। संस्थान किसी भी कारण से डाउनलोडिंग सुविधा में देरी/किठनाइयों/दुर्गमता के लिए जिम्मेदार नहीं होगा।
- 2.2.7. बोली की तैयारी के संबंध में होने वाली सभी लागत, शुल्क और व्यय अनुबंधित फर्म द्वारा वहन किए जाएंगे और संस्थान उस पर कोई भी दायित्व स्वीकार नहीं करेगा।
- 2.2.8. बोलीदाताओं द्वारा उद्धृत दरों में श्रम शुल्क, परिवहन शुल्क और जीएसटी (वस्तु एवं सेवा कर केंद्रीय, राज्य और अंतरराज्यीय) और सभी लागू कर शामिल होंगे। अनुबंध के निष्पादन के दौरान उद्धृत दरें दृढ़ रहेंगी और इसमें कोई वृद्धि नहीं होगी। आयकर और अन्य सभी वैधानिक कटौतियाँ जैसे श्रम उपकर आदि प्रचलित नियमों के अनुसार बिल से काट लिया जाएगा।
- 2.2.9. किसी भी कर/शुल्क/शुल्क/अधिभार/प्रभार/लागत, यदि कोई हो, के विरुद्ध भा.प्रौ.सं. गोवा को छूट, यदि लागू हो या बाद में पुरस्कार के बाद भा.प्रौ.सं. गोवा से मांगी गई हो, ठेकेदार द्वारा बिना किसी विवाद के आईआईटी गोवा को दे दी जाएगी।
- 2.2.10. बोली वैधता: बोली तकनीकी बोली खोलने की तारीख से 120 दिनों तक वैध रहेगी।
- 2.2.11. कार्य में उपयोग से पहले सामग्री/स्पेयर पार्ट्स को प्रभारी अभियंता को दिखाया जाना चाहिए। कार्य को संतोषजनक ढंग से पूरा करने के लिए आवश्यक सामग्री अनुमोदित गुणवत्ता, मेक, ग्रेड आदि की होनी चाहिए और जहां भी लागू हो और प्रभारी अभियंता द्वारा अनुमोदित प्रासंगिक भारतीय मानक विनिर्देशों (नवीनतम संशोधन) की पृष्टि करनी चाहिए। निर्माण से पहले सभी सामग्री को गुणवत्ता जांच और अनुमोदन के लिए प्रभारी इंजीनियर को दिखाया जाना चाहिए।
- 2.2.12. यदि ठेकेदार निर्धारित समय सीमा के भीतर काम पूरा करने में विफल रहता है तो कार्य आदेश मूल्य का 0.5% का जुर्माना साप्ताहिक आधार लगाया जाएगा, अधिकतम 10% पर लगाया जाएगा और इसे चालू/अंतिम बिल से काट लिया जाएगा।
- 2.2.13. दृढ़ मूल्य: अनुबंध के तहत गतिविधियों को निष्पादित करने के लिए बोलीदाता की उद्धृत दरें/कीमतें काम पूरा होने तक स्थिर रहेंगी और किसी भी परिस्थित में कोई वृद्धि नहीं होगी।
- 2.2.14. भुगतान साइट पर किए गए वास्तविक माप के आधार पर एक अंतिम बिल में किया जाएगा। पूर्ण मूल्य का 5% सुरक्षा जमा और पूर्ण मूल्य का 1% श्रम उपकर अंतिम बिल से काटा जाएगा। भारतीय प्रौद्योगिकी संस्थान गोवा के पास दोष देयता अविध के एक वर्ष की अविध के लिए सुरक्षा जमा राशि को बनाए रखा जाएगा। यदि ठेकेदार द्वारा आपूर्ति की गई खराब कारीगरी या सामग्री के कारण कार्य पूरा होने की तारीख के एक वर्ष के भीतर कार्य में किसी दोष का पता चलता है, तो ठेकेदार द्वारा इसे भारतीय प्रौद्योगिकी संस्थान गोवा को मुफ्त में ठीक किया जाएगा। यदि ठेकेदार इस दोष को तुरंत दूर करने में विफल रहता है, तो ठेकेदार के जोखिम और लागत पर भारतीय प्रौद्योगिकी संस्थान द्वारा इसे ठीक किया जाएगा। उक्त दोषों को दूर करने में आने वाली राशि की वसूली सिक्योरिटी डिपॉजिट राशि/बिल से की जाएगी।



- 2.2.15. यदि बोलीदाता द्वारा दी गई कोई भी जानकारी झूठी/मनगढ़ंत पाई जाती है, तो उसकी बोली अस्वीकार कर दी जाएगी और रद्द मानी जाएगी। भले ही अनुबंध पर हस्ताक्षर करने के बाद किसी भी चरण में इस तरह की हेराफेरी का पता चलता है, इससे अनुबंध समाप्त हो जाएगा और ठेकेदार अभियोजन के लिए उत्तरदायी होगा। ऐसे मामलों में बोली लगाने वाले को अगले 02 (दो) वर्षों के लिए भारतीय प्रौद्योगिकी संस्थान गोवा में भविष्य की निविदा प्रक्रिया में भाग लेने से रोक दिया जाएगा।
- 2.2.16. सफल बोलीदाता द्वारा कार्य के लिए नियुक्त तकनीशियनों के पास प्रासंगिक कार्य अनुभव होना चाहिए। तकनीशियनों की शैक्षणिक योग्यता कम से कम इलेक्ट्रिकल में आईटीआई होनी चाहिए और तकनीशियनों को इस एनआईटी के भाग-बी वित्तीय बोली में दिए गए सभी कार्यों को निष्पादित करने में सक्षम होना चाहिए।
- 2.2.17. यह ठेकेदार की जिम्मेदारी होगी कि वह कार्य की निगरानी के लिए एक योग्य और अनुभवी पर्यवेक्षक को नियुक्त करे और कार्य में प्रगति की सूचना प्रभारी अभियंता को दे।
- 2.2.18 किसी भी संदेह की स्थिति में इस निविदा आमंत्रण सूचना के अंग्रेजी संस्करण पर विचार किया जाएगा।
- 2.2.19 यह ठेकेदार की जिम्मेदारी होगी कि वह आवश्यक सावधानियों और पर्याप्त सुरक्षा उपायों के साथ कार्य को पूरा करे। ठेकेदार कार्य को पूरा करने के लिए आवश्यक सभी आवश्यक सुरक्षा उपकरणों जैसे हेलमेट, दस्ताने आदि की व्यवस्था करेगा। किसी भी खतरे/दुर्घटना की स्थिति में, ठेकेदार पूरी तरह से जिम्मेदार होगा।
- 2.3. निविदा प्रस्त्त करने के लिए सूचना

- 2.3.2. नियत तिथि एवं समय के बाद प्राप्त निविदाओं पर विचार नहीं किया जाएगा।
- 2.3.3. निविदाएं एक सीलबंद मास्टर लिफाफे में प्रस्तुत की जाएंगी (जो कागजों को मोड़ने से रोकेगी) जिस पर निविदा आमंत्रण सूचना संख्या भा.प्रौ.सं. गोवा/नि. एवं सं.प्र.प्र./2023/035 दिनांक 13 दिसंबर 2023, के साथ "120 वर्ग मीटर प्रीफैब केबिन-बी के लिए बाहरी और आंतरिक विद्युत कार्य" लिखा होगा। जिसमें तीन अलग-अलग सीलबंद लिफाफे (कागजों को मोड़ने से रोकना), प्रत्येक पर स्पष्ट रूप से निम्नलिखित तरीके से क्रमशः

1.3. ELIGIBILITY CRITERIA

- 1.3.1. Reputed electrical contractors having appropriate (MV or above) valid electrical contractor's license issued by Govt. of Goa and possessing the contractor's license for not less than three years are eligible. If the bidder does not have a valid contractor license then he/she must have the willingness from a licensed contractor for supervising the work to whom such license is issued by the Govt. of Goa for carrying out the electrical work in MV category or above. The willingness letter (as given in Appendix-D) along with a copy of the valid license (attested by the bidder and license holder) must be enclosed. The license must be valid during the execution period of the work.
- 1.3.2. The bidder must have experience in the similar nature of works awarded by Government / Semi Government Organizations/ Government Funded Autonomous Organization.
- 1.3.3. The bidder must have successfully completed at least EITHER 1 (ONE) similar work of value equal to or greater than 80%(i.e. Rs. 2,67,000/-) of the estimated cost OR 2 (TWO) similar works, each of value equal to or greater than 60%(i.e. Rs. 2,00,000/-) of the estimated cost OR 3 (THREE) similar works, each of value equal to or greater than 40%(i.e. Rs. 1,33,500/-) of the estimated cost with Government/ Semi-government/ PSU/ Government Funded Autonomous Organization. The above mentioned works must have been completed during the last 7 (seven) years preceding the last date of the month of tender submission. The work order copy and the completion certificate in CPWD format may be enclosed. The completion certificate should bear the name of the contractor, awarded value of work, completed value of work, stipulated date of completion, actual date of completion, penalty levied if any et cetera signed by not less than the rank of EE.

Note:

- i. The estimated cost is Rs. 3,33,092/- (Rupees Three Lakhs Thirty-Three Thousand and Ninety-Two Only).
- ii. Similar works shall mean: Internal and external electrical works as described CPWD General Specifications for Electrical Works Part 1 (Internal) 2023 and Part 2 (External) 2023.
- 1.3.4. A Certificate/Undertaking on the letter head of the Company to the effect that the bidder/Manufacturer has not been blacklisted anywhere in India or abroad by any organization. A self- certification to this effect is required to be enclosed as given in Appendix-A.
- 1.3.5. Annual turnover for each of the FY2020-21, FY2021-22 & FY2022-23 of the bidder as per ITCC certified by the CA shall not be less than the estimated cost (i.e. Rs. 3,33,092/-).
- 1.3.6. The bidder should enclose the self-attested copies of the following;
 - A. Valid Electrical Contractors Licence issued by Government of Goa as per 1.3.1
 - B. GST Registration.
 - C. PAN



- D. Work order copy and completion certificate from the client as per the criteria 1.3.2 & 1.3.3
- E. Copy of EPF and ESI registration. If the bidder is not registered with EPF and ESI then a letter on the letter head of the firm must be submitted with the reason thereof and the firm will be responsible for any consequence for non-compliance of EPF/ESI.
- F. Annual turnover certificate as per 1.3.6 above.

2. INFORMATION TO BIDDERS

2.1. SCOPE OF WORK

- 2.1.1 Scope of work shall include supply, installing, testing and commissioning all the items as given in Part B (Financial Bid) of this NIT.
- 2.1.2 The items as given in Part B (Financial Bid) of this NIT shall be executed in accordance with the CPWD's "General Specifications for Electrical Works Part 1 (Internal) 2023 and Part 2 (External) 2023."

2.2. GENERAL INSTRUCTIONS

- 2.2.1 Bidding documents are to be downloaded from websites: https://iitgoa.ac.in/tenders/.
- 2.2.2 This bid document shall be read in conjunction with CPWD's GCC (General Conditions of Contract) and the applicable specifications as given in General Specifications for Electrical Works Part 1 (Internal) 2023 and Part 2 (External) 2023 & Works Manual 2022 and its SOP's. These documents shall hold good for this contract unless otherwise mentioned. However the cost of escalation (10 CA, 10 CC et cetera) and secured advance against material shall not be applicable to this contract.
- 2.2.3 If the participating bidders are willing to attend the pre-bid meeting then such bidders must send a mail to je.electrical@iitgoa.ac.in keeping CC to ex.eng@iitgoa.ac.in & estate@iitgoa.ac in along with their queries. The relevant queries will be answered in the pre-bid meeting which will happen in the C&EMD office. Any reply to queries that affects the tender shall form part of the NIT and corrigendum for the same will be issued and the contractor shall quote accordingly.
- 2.2.4 The bidder shall visit and inspect the site and obtain all information on his own responsibility and at own cost, which may be necessary for the purpose of quoting and submitting the tender. No excuse or ignorance as to site conditions and local information shall be accepted after awarding of the contract. Access to the site will be granted by the Engineer-in-charge on all working days within working hours.
- 2.2.5 Completion certificate issued by the Competent Authority on the letterhead of the respective organization will only be considered as credential. If the Completion certificate issued by Competent Authority does not reflect the type of work, then the final bill or Schedule of Quantity of the qualifying works is required to be attached along with the Completion certificates. The completion certificate shall contain details such as name of the work, date of starting of the work, actual completion date, schedule date of completion, reasons for delay if any, final value, penalty levied if any and shall be signed by an officer not below the rank of EE.



- 2.2.6 The bidding document (consisting of the schedule of quantities of various types of items to be executed, the set of terms and conditions of the contract and other documents / drawings, if any), Corrigendum (if any) shall be published only on these websites https://iitgoa.ac.in/tenders/. The institute shall not be responsible for any delay / difficulties / inaccessibility of downloading facility for any reason whatsoever.
- 2.2.7 All costs, charges & expenses that may be incurred in connection with the preparation of the bid shall be borne by contracting firm and the Institute accepts no liability whatsoever thereon.
- 2.2.8 Rates quoted by the bidders shall be inclusive of labour charges, transportation charges and GST (Goods and Services Tax Central, State and Interstate) and all applicable taxes. The rates quoted shall remain firm during the execution of the contract and it shall not attract any escalation. Income Tax and all other statutory deductions like labour cess etc. will be deducted from the bill as per prevailing rules.
- 2.2.9 Exemption to IIT Goa against any tax/ duty/ fee/ surcharge/ charge/ cost, if any, found applicable or sought later from IIT Goa after award shall be passed on to IIT Goa by the contractor without dispute.
- 2.2.10 Bid Validity: Bid shall remain valid for 90 days from the date of opening of technical bids.
- 2.2.11 Material/spare parts should be shown to the Engineer-in-Charge before use in the work. Materials required for satisfactory completion of work shall be of approved quality, make, grade etc. and confirming to the relevant Indian Standard Specifications (Latest revision) wherever applicable and as approved by the Engineer-in-charge. All material before erection should be shown to the engineer-in-charge for quality check and approval.
- 2.2.12 If the contractor fails to complete the work within the stipulated time frame then a penalty of 0.5% of the work order value will be imposed on a weekly basis for a maximum of 10% and the same will be deducted from the running/final bill.
- 2.2.13 Firm Price: Bidder's quoted Rates/Prices for executing the activities under the Contract shall remain firm till the completion of work & shall not attract any escalation under any circumstances whatsoever.
- 2.2.14 Payment shall be made in one final bill on the basis of actual measurement carried out at site. Security deposit of 5% and labour cess of 1% of the completed value will be deducted from the final bill. Security deposit shall be retained with Indian Institute of Technology Goa for a period of one year of defect liability period. If any defect in the work is detected within one year of completion date due to bad workmanship or material supplied by the contractor, the same shall be made good by the contractor free of cost to Indian Institute of Technology Goa. In case the contractor fails to rectify the defect promptly, the same will be rectified and made good by the Indian Institute of Technology at the risk and cost of the contractor. The amount incurred in rectifying the said defects shall be recovered from the security deposit amount/bill.
- 2.2.15 If any information furnished by the bidder is found as false / fabricated, then his bid will be rejected and treated as canceled. Even if such manipulation is detected at any stage after signing of the contract, it would lead to termination of the contract and the contractor shall be



liable towards prosecution. In such cases the bidder will be debarred from participation in future tendering process in IIT Goa for next 02 (Two) years.

- 2.2.16 The technicians deputed for the job by the successful bidder must have relevant work experience. The education qualification of the technicians must be at least ITI in *Electrical* and the technicians must be capable of executing all the jobs as given in *Part-B Financial Bid* of this NIT.
- 2.2.17 It will be the responsibility of the contractor to depute a qualified and experienced supervisor for supervising the work and that the progress in work is reported to the Engineer in charge.
- 2.2.18 In the event of any doubts, the English version of this NIT will be considered.
- 2.2.19 It will be the responsibility of the contractor to carry out the work with necessary precautions and adequate safety measures. The contractor shall arrange all the necessary safety equipments such as helmet, gloves, et cetera required for carrying out the work. In the event of any hazard/accident, the contractor will solely be responsible.

2.3. SUBMISSION OF TENDER

- 2.3.1 The sealed tenders must be submitted to the C&EMD Office, IIT Goa, Goa College of Engineering Campus, Farmagudi, Ponda Goa-403401 on or before 02nd of January 2024 up to 15:00 hrs, or as per Corrigendum otherwise.
- 2.3.2 Tenders received after the due date and time will not be considered.
- 2.3.3 Tenders shall be submitted in a sealed Master envelope(which will prevent folding of papers) super scribed "External and Internal Electrical Works for 120 Sq.m Prefab Cabin B" with the NIT No. IIT GOA/C&EMD/2023/035 dated 13th of December 2023, containing three separate sealed envelope (preventing folding of papers), in the following manner:
- 2.3.4 Envelope-1 (super scribed as "EMD and Tender Fees" or "Bid Security Declaration") will consist of two Demand Draft one for EMD and the other for Tender Fees in the favor of IIT Goa. MSME bidders are exempted from EMD and tender fees. Instead MSME bidders are required to furnish "Bid Security Declaration" as given in Annexure C.
- 2.3.5 Tender without submission of EMD and Tender fees(or Bid Security Declaration for MSME bidders) will be summarily rejected.
- 2.3.6 Envelope-2 (super scribed as "Technical Bid") will consist of:
 - (i) Covering letter of the technical offer signed by the firm's authorized signatory.
 - (ii) Documents establishing the identity and authenticity of the bidder/ bidding firm.
 - (iii) Self-certified copies of all the documents in support of eligibility of bidder as per the clause 1.3 of this tender document.



- (iv) Undertaking by the bidder as per Appendix-A
- (v) Complete tender document, each page duly signed and stamped by the bidder or his/her authorized signatory as a token of acceptance of the terms and conditions. The name of the person signing the bid documents with his designation in the firm/company must be clearly mentioned. Financial bid should not be enclosed here. The person signing the document should have authorisation from the proprietor/Competent Authority of Organisation/Director etc.
- 2.3.7 Envelope-3 (super scribed as "Financial Bid") will consist of the Financial Bid duly filled-in, signed by the bidder and stamped.

2.4. EVALUATION OF BIDS AND AWARD OF WORK

- 2.4.1. The Technical Bid of bidders will be opened on the specified date and time as mentioned in the NIT(or corrigendum if issued) at the C&EMD Office, IIT GOA, GEC Campus, Farmagudi, Ponda Goa in the presence of willing bidders or their authorized representatives.
- 2.4.2. The Envelope 1 shall be opened first. Bids shall be checked for EMD and tender fees(or Bid Security Declaration for MSME bidders). Only those bids found to have submitted EMD and tender fees(or Bid Security Declaration for MSME bidders) shall be considered for opening of Envelope 2.
- 2.4.3. Evaluation of Technical Bid: The bids received will then be scrutinized on the basis of eligibility criteria mentioned at para 1.3 of Notice Inviting Tender. Bids found not meeting the eligibility criteria shall be considered non-responsive and shall be rejected summarily.
- 2.4.4. Date, time and place of opening of Financial Bid will be informed after evaluation of the Technical Bid to the Technically Qualified Bidders only.
- 2.4.5. IIT Goa retains the right to revert back to individual bidders with further clarifications / queries on the Technical Bid. The bidder has to respond to the queries within the specified time mentioned in the covering letter failing which they may be considered as non-responsive and shall be rejected.
- 2.4.6. **Evaluation of Financial Bids:** The financial bid should be filled in Indian rupees inclusive of all taxes, material, labour, transport charges etc. Financial Bids opened as above will be checked for arithmetical errors. The rates and amount should be filled in both numerical and word form. In the event of dispute the rates mentioned in words will be considered final. The work will be finalized on lowest quotation basis.
- 2.4.7. The lowest bidder shall be issued work order for carrying out the "External and Internal Electrical Works for 120 Sq.m Prefab Cabin", and such bidder is required to furnish a Performance Guarantee within seven working days from the date of issue of work order. If the bidder fails to submit the Performance Guarantee, then the work order may be canceled including debarring the party from participation in retendering. In such case the Earnest Money Deposit shall be forfeited.



- 2.4.8. Agreement (Contract) consisting of complete tender document including conditions, bill of quantities, technical proposal and specialized services, drawings, if any, and acceptance thereof together with any correspondence leading thereto, shall be drawn and signed with the awardee after issue of Work Order and submission of PBG. Agreement format is enclosed in Appendix E. The agreement shall be made on a Rs. 100/- stamp paper signed by the contractor and Registrar, IIT Goa, counter signed by two engineers.
- 2.4.9. In case of any ambiguity/overwriting/rewriting/correction in financial bid, the CPWD guideline shall be followed.
- 2.4.10. Conditional tender will not be accepted.
- 2.4.11. Tender not submitted as per laid down format or incomplete tenders shall not be accepted.
- 2.4.12. Defect liability period for this contract will be for one year from the date of completion of work.
- 2.4.13. In case of any doubts the English version of this NIT will be considered.

AND whereas the said drawing numbered one to xxxxxxxxxxxxxxx inclusive of specifications and the priced schedule of quantities have been signed by or on behalf of the parties hereto.

AND whereas the contractor has deposited cash in bank through (<u>Payment Form & Details</u>) with IIT Goa as a security for the due performance & EMD respectively of this agreement as provided in the said condition.

- 1. WHEREAS the BIDDER is a private company / public company / Government undertaking / partnership/ or any legally valid entity constituted in accordance with the re levant law in the matter and the BUYER is an Autonomous body that comes under the Ministry of Education Government of India.

NOW, THEREFORE,

To avoid all forms of corruption by following a system that is fair, transparent and free from any influence/prejudiced dealings prior to, during and subsequent to the currency of the contract to be entered into with a view to:

Enabling the BUYER to obtain the desired Services at a competitive price in conformity with the defined specifications by avoiding the high cost and the distortionary impact of corruption on public procurement, and

The Bidder(s)/Contractor(s) will not, directly or through any other person or firm, offer, promise or give to any of the Principal's employees involved in the tender process or the execution of the contract or to any third person any material or other benefit which he/she is not legally entitled to, in order to obtain in exchange any advantage of any kind whatsoever during the tender process or during the execution of the contract.
 - B. The Bidder(s)/Contractor(s) will not enter with other Bidders into any undisclosed agreement or understanding, whether formal or informal. This applies in particular to prices, specifications, certifications, subsidiary contracts, submission or non-submission of bids or any other actions to restrict competitiveness or to introduce cartelization in the bidding process.
 - C. The Bidder(s)/Contractor(s) will not commit any offence under the relevant IPC/PC Act; further, the Bidder(s)/Contractor(s) will not use improperly, for purposes of competition or personal gain, or pass on to others, any information or document provided by the Principal as part of the business relationship, regarding plans, technical proposals and business details, including information contained or transmitted electronically.
 - D. The Bidder(s)/Contractor(s) will, when presenting their bid, disclose any and all payments made, is committed to or intends to make to agents, brokers or any other intermediaries in connection with the award of the contract.
 - E. Bidder(s)/Contractor(s) who have signed the Integrity Pact shall not approach the courts while representing the matter to IEMs and shall wait for their decision in the matter.
- 2. The Bidder(s)/contractor(s) will not instigate third persons to commit offenses outlined above or be an accessory to such offenses.

Section 3 - Disqualification from the tender process and exclusion from future contracts

- 1. If the Bidder, before contract award, has committed a transgression through a violation of Section 2 or in any other form such as to put his reliability or credibility as Bidder into question, the Principal is entitled to disqualify, the Bidder from the tender process or to terminate the contract, if already signed, for such reason.
 - A. If the Bidder/Contractor/Supplier has committed a transgression through a violation of Section 2 such as to put his reliability or credibility into question, the Principal is also entitled to exclude the Bidder/Contractor/Supplier from future contract award processes. The imposition and duration of the exclusion will be determined by the severity of the transgression. The severity will be determined by the circumstances of the case. In particular the number of transgressions, the position of the transgressors within the company hierarchy of the Bidder and the amount of the damage, the exclusion will be imposed for a minimum of 6 months and a maximum of 3 years.
 - B. A transgression is considered to have occurred if the Principal, after due consideration of available facts and evidence within his/her knowledge concludes that there is a reasonable ground to suspect a violation of any commitment listed under Section 2 i.e. "Commitments of Bidder(s)/Contactor(s)".
 - C. The Bidder accepts and undertakes to respect and uphold the Principal's absolute right to resort to and impose such exclusion and further accepts and undertakes not to challenge or question such exclusion on any ground, including the lack of any hearing before the decision to resort to such exclusion is taken. This undertaking is given freely and after obtaining independent legal advice.
 - D. If the Bidder/Contractor/Supplier can prove that he has restored/recouped the damage caused by him and has installed a suitable corruption prevention system, the Principal may revoke the exclusion prematurely."



Section 4 – Compensation for Damages

- 1. If the Principal has disqualified the Bidder(s) from the tender process prior to the award according to Section 3, the Principal is entitled to demand and recover the damages equivalent to the Earnest Money Deposit/Bid Security.
- 2. If the Principal has terminated the contract according to Section 3, or if the Principal is entitled to terminate the contract according to Section 3, the Principal shall be entitled to demand and recover from the Contractor liquidated damages of the Contract value or the amount equivalent to Performance Bank Guarantee.

Section 5 - Previous transgression

- 1. The Bidder declares that no previous transgressions occurred in the last three years with any other Company in any country conforming to the anti-corruption approach or with any Public Sector Enterprise in India that could justify his exclusion from the tender process.
- 2. If the Bidder makes an incorrect statement on this subject, he can be disqualified from the tender process or action can be taken as per the procedure mentioned in "Guidelines on Banning of business dealings".

Section 6 - Equal treatment of all Bidders/ Contractors / Subcontractors

- 1. In the case of Sub-contracting, the Principal Contractor shall take responsibility of the adoption of the integrity Pact by the Sub-contractor.
- 2. The Principal will enter into agreements with identical conditions as this one with all Bidders and Contractors.
- 3. The Principal will disqualify from the tender process all bidders who do not sign this Pact or violate its provisions.

Section 7 - Criminal charges against violating Bidders/ Contractors / Subcontractors

If the Principal obtains knowledge of the conduct of a Bidder, Contractor or Subcontractor, or of an employee or a representative or an associate of a Bidder, Contractor or Subcontractor which constitutes corruption, or if the Principal has substantive suspicion in this regard, the Principal will inform the same to the Chief Vigilance Officer.

Section 8 – Independent External Monitor

- 1. The Principal appoints a competent and credible Independent External Monitor for this pact after approval by the Central Vigilance Commission. The task of the Monitor is to review independently and objectively, whether and to what extent the parties comply with the obligations under this agreement.
- 2. The Monitor is not subject to instructions by the representatives of the parties and performs his/ her functions neutrally and independently. The Monitor would have access to all contract documents, whenever required. It will be obligatory for him/her to treat the information and documents of the Bidders/contractors as confidential. He/she reports to the Director, IIT Goa.
- 3. The Bidder(s)/contractor(s) accepts that the Monitor has the right to access without restriction to all Project documentation of the principal including that provided by the contractor. The contractor will also grant the Monitor, upon his/her request and demonstration of a valid interest, unrestricted and unconditional access to their project documentation.
- 4. The Monitor is under contractual obligation to treat the information and documents of the Bidder(s)/contractor(s)/Sub-contractor(s) with confidentiality. The Monitor has also signed declarations on 'Non- Disclosure of Confidential Information' and of 'Absence of Conflict of Interest'. In case of any conflict of interest arising at a later date, the IEM shall inform Director, IIT Goa and recuse himself/herself from that case.



- 5. The Principal will provide to the Monitor sufficient information about all meetings among the parties related to the Project provided such meetings could have an impact on the contractual relations between the principal and the contractor. The parties offer to the Monitor the option to participate in such meetings.
- 6. As soon as the Monitor notices, or believes to notice, a violation of this agreement, he/she will so inform the Management of the principal and request the Management to discontinue or take corrective action, or to take other relevant action. The monitor can in this regard submit non-binding recommendations. Beyond this, the Monitor has no right to demand from the parties that they act in a specific manner refrain from action or tolerate action.
- 7. Monitor will submit a written report to the Director, IIT Goa within 8 to 10 weeks from the date of reference or intimation to him by the Principal and, should the occasion arise, submit proposals for correcting problematic situations.
- 8. If the Monitor has reported to the Director, IIT Goa, a substantiated suspicion of an offense under the relevant IPC/ PC Act, and the Director, IIT Goa has not, within the reasonable time taken visible action to proceed against such offense or reported it to the Chief Vigilance Officer, the Monitor may also transmit this information directly to the Central Vigilance Commissioner.
- 9. The word 'Monitor' would include both singular and plural.

Section 9 - Pact Duration

- 1. This pact begins when both parties have legally signed it. It expires for the contractor 12 months after the last payment under the contract and for all other Bidders 6 months after the contract has been awarded.
- If any claim is made/lodged during this time, the same shall be binding and continue to be valid despite the lapse of this pact as specified above, unless it is discharged/determined by the Director, IIT Goa.

Section 10 - Other Provisions

- 1. Changes and supplements as well as termination notices need to be made in writing. Side agreements have not been made.
- 2. Should one or several provisions of this agreement turn out to be invalid, this remainder of this agreement remains valid. In this case, the parties will strive to come to an agreement with their original intentions.
- 3. Issues like Warranty/ Guarantee etc. shall be outside the purview of IEMs.
- 4. In the event of any contradiction between the Integrity Pact and its Annexures the Clause in the Integrity Pact will prevail.

Section 11 - Facilitation of Investigation

1. In case of any allegation of violation of any provisions of this Pact or payment of commission, the BUYER or its agencies shall be entitled to examine all the documents including the Books of Accounts of the Bidder and the Bidder shall provide necessary information and documents in English and shall extend all possible help for the purpose of such examination.

Section 12 - Law and Place of Jurisdiction

This pact is subject to Indian Law. The place of performance and jurisdiction is the seat of the BUYER.

Section 12 – Other Legal Actions

The actions required in this Integrity Pact are without prejudice to any other legal action that may follow in accordance with the provisions of the extant law in force relating to any civil or criminal; proceedings.
