Terms & Conditions:

- 1) The rates quoted must be valid for **90 days** from the date of opening of the quotation.
- 2) The bidder shall quote their rates considering all prevalent taxes/ cess like GST, workers cess or any other tax on material /work as applicable on the last date of bid submission and nothing extra shall be paid to the contractor on this account. All such taxes as applicable shall be paid by the contractor himself. The institute shall deduct from the RA bills, the TDS as applicable
- 3) Those contractors not registered on the website mentioned above, are required to get registered beforehand. The necessary training materials including the videos with step-to-step process are available on CPP portal. The institute shall not be responsible for whatsoever case in this regard.
- 4) The intending bidder must have valid class digital signature to submit the quotation. Contractor can upload documents in the form of JPG format and PDF format only.
- 5) IIT Goa reserves the right to increase or decrease the quantity and/or amount of work. In this regard, decision of IIT Goa will be final.
- 6) IIT Goa reserves the right to reject any quotation or part or the whole of inviting quotation process without assigning any reason. The decision of the Competent Authority of IIT Goa will be final and binding.
- 7) Mere becoming the lowest bidder, prior to financial bid scrutiny will not give any right to the lowest bidder to claim that he is successful in the bidding process. The successful bidder (L1) shall be decided only after following due procedure.
- 8) The work shall be carried out strictly in accordance with the terms, conditions and specifications as per CPWD norms, in the approved workmanlike manner and as per standard practice. The decision of Engineer-in-Charge in this regard shall be final and binding.
- 9) Materials required for satisfactory completion of work shall be of approved quality, make, grade etc. and of/or conforming to the Indian Standard Specifications (Latest revision) wherever applicable and approved by the Engineer-in-charge before use.
- 10) The agency must make the arrangements of scaffolding and other required machinery at its own cost.

- 11) IIT Goa will provide water and electricity required for the works.
- 12) List of documents to be scanned and uploaded within the period of quotation submission for meeting technical eligibility criteria:
- (i) Earnest Money Deposit Scanned copy of Bank transaction slip
- (ii) GST Registration Certificate
- (iii) PAN card duly attested by the firm.
- (iv) Copy of Bank Account details viz cancel cheque
- (v) Should have satisfactorily completed the works as mentioned below during the last Seven years ending last day of the month previous to the one in which quotations are invited.
 - Three similar works each costing not less than 40% of estimated cost put to quotation
 - or two similar works each costing not less than 60% of estimated cost put to quotation
 - or one similar work costing not less than 80% of estimated cost put to quotation. Similar work shall mean: Cleaning & Disinfection of water storage tanks

The value of executed works shall be brought to current costing level by enhancing the actual value of work at simple rate of 7% per annum; calculated from the date of completion to previous day of last day of submission of quotations.

Contractor shall submit completion certificate for such works for pre-qualification. Pre- qualification application received without such experience (Completion Certificate) shall be summarily rejected. Bidder shall submit self-attested certificate of completion certificate(s), issued by the officer not below the rank of Executive Engineer or equivalent in case of Govt. works. For non-Govt. work the completion certificate shall be accompanied with TDS certificate indicating payment made to the firm against the work. Completion certificate must clearly indicate.

- 1. Name of work
- 2. Stipulated date of start and actual date of completion.
- 3. Gross Value of work done
- 4. That the work has been completed satisfactorily.
- 5. Full address of client, officer issuing the certificate & location where work is executed.
- (vi) Entire quotation document along with the signature of authorized person and seal of the firm as atoken of acceptance of terms and conditions of the quotation.
- 13) Bidder is also required to submit a cover letter mentioning the details of the firm viz. Name, contact details, address, authorized person and list of various natures of work executed in past.
- 14) Applicant has to deposit Online payment of Rs. 1400./- (Rupees One Thousand Four hundred only) towards refundable EMD.

15) The EMD of the successful bidder will be returned without any interest after submission of Performance Guarantee. The earnest money of unsuccessful bidders shall be returned after financial evaluation/award of contact.

<u>Note:</u> The MSME firms registered in NSIC under PP policy are exempted from payment of EMD for supply of goods and services only. They are not relaxed for works contracts. No other relaxation will be allowed.

- 16) Performance Guarantee The Contractor has to submit performance guarantee @ 10% of quotation accepted value within 7 days from the date of issue of LoA/Work Order, in form of Demand Draft/FDR/Bank Guarantee Bonds of any Scheduled bank or the State Bank of India in accordance with the prescribed form, which shall be valid for period of 6 months beyond the date of completion of defect liability period. After completion of work the performance guarantee shall become Security Deposit of same value and returned to the contractor without any interest after the completion of the defect liability period.
- 17) Warranty / Defect Liability Period (if any) Six month from the date of completion of work.
- 18) Liquidated Damage: If the contractor fails to carry out the work on or before the stipulated date, then a penalty @ 2% (two percent) per month of delay subject to maximum of 5% of work order value to be computed on per day basis based on quantum of damage suffered due to stated delay on the part of Contractor.

- 19) **Payment Clause:** Payment will be only after successful completion of work duly certified by the Engineer-In-Charge based on the actual measurement of work done only.
- 20) Failing to comply with any of the terms & conditions of the contract, the EMD/Performance Guarantee shall be forfeited.
