NOTICE INVITING QUOTATION

Sealed item rate quotations are invited from approved and eligible contractors for the works "Renovation of Cricket Practice Pitch Area - Hostel Premises". The schedule of quantities is stated in Annexure A. The terms & conditions of work are as stated below:

Terms & Conditions:

- 1) Validity of the quotation should be 60days.
- 2) The total estimated cost of the works is Rs. 1,20,650/- (Inclusive of GST).
- 3) The bidder has to submit the tender fee amounting to Rs. 500/- and Earnest Money Deposit of Rs. 2,420/- (Both in the form of Demand Draft drawn in the favour of IIT Goa Main Account payable at Goa). The MSME registered firms having registration for similar works as mentioned above may submit the Bid Security Declaration in lieu of EMD.
- 4) Bid Security declaration should be submitted as per the format attached in Annexure B. The agencies who fail to submit the Earnest Money Deposit / Bid Security Declaration will be out rightly rejected.
- 5) The work should be completed within a stipulated time of one month reckoned from the 7th day from the date of release of work order.
- 6) The commencement and completion of the work within the specified time frame will be the responsibility of the bidder, failing which a compensation @ 1% of the accepted tender amount will be charged per day subjected to a maximum of 10% of the total accepted tender amount.
- 7) The work shall be carried out strictly in accordance with the terms, conditions and specifications as per CPWD norms, in the approved workmanlike manner and as per standard practice.
- 8) All the quoted rates must be inclusive of GST.
- 9) Materials required for satisfactory completion of work shall be of approved quality, make, grade etc. and of/or conforming to the Indian Standard

Specifications (Latest revision) wherever applicable and approved by the Engineer-in-charge before use.

- 10) Payment will be done on satisfactory completion of the work. A security amount @ 5% of the completed value of work will be deducted from the final bill and the same will be refunded after the defect liability period of 1 year.
- 11) The agency must make the arrangements of scaffolding and other required machinery at its own cost.
